

## **Rules for visitors to the Xawery Dunikowski Museum of Sculpture – Branch of the National Museum in Warsaw**

Visiting the Xawery Dunikowski Museum of Sculpture at the Królikarnia Palace and the Sculpture Park is only permitted if the sanitary regulations set out in valid legal regulations are adhered to.

### **GENERAL PRINCIPLES**

1. Visitors are required to maintain a distance of 2 meters from one another while in the Museum or in the Park, unless they are taking care of a child (up to 13 years of age), a person holding a disability certificate, a disability degree certificate or a special education needs certificate, or of a person with limited mobility due to their health condition.

The social distancing obligation shall not apply to people who live together or maintain a common household.

2. Visitors are required to follow strict hygiene rules. They are recommended to cover their mouth and nose while inside the Museum and in the Park (always when sneezing or coughing), avoid touching any surfaces and frequently wash and disinfect their hands.

### **XAWERY DUNIKOWSKI MUSEUM OF SCULPTURE**

1. The Museum is open from Tuesday to Sunday between 10 a.m. and 4 p.m.
2. The Museum is closed on Mondays.
3. Last admission to the exhibition area is half an hour before the Museum closing time.
4. A valid ticket or invitation is required to enter the Museum.

Tickets may be purchased at specific locations within the Museum premises. The ticket is also valid for a single entry into the Main Building of the National Museum in Warsaw until 30 September 2020.

5. On Tuesdays, admission to the Museum is free. Please note that a free ticket is valid only on the day on which it is collected from the Museum.

6. No more than 20 people may tour the Museum's temporary exhibition at the same time.

7. Visitors should cover their mouth and nose with clothing, a face mask or shield, as per Article 18(2)(2) and (3) of the Regulation of the Council of Ministers of 2 May 2020 (Journal of Laws 2020 item 792). The above obligation shall not apply to children under the age of 4 or to any persons who cannot cover their mouth or nose due to health reasons, a pervasive developmental disorder, mental health disorder, mild, moderate or profound intellectual disability or persons who have difficulties with covering or uncovering their mouth or nose on their own.

8. Visitors shall cover their mouth and nose using their own means of personal protection.

9. The exhibition may only be visited individually and group visits are prohibited (with the exception of parents accompanying children under the age of 13, persons who live together or maintain a common household and carers of disabled persons).

10. While visiting the Exhibition, visitors shall be prohibited from gathering, and shall be required to maintain a distance of 2 meters from one another (with the exception of parents accompanying children under the age of 13, people who live together or Visitors are required to disinfect their hands before entering the exhibition area. The Museum shall provide visitors with hand sanitizer.

maintain a common household, as well as carers of disabled persons).

11. Museum guide services shall be temporarily suspended and third-party guide services shall be prohibited.

12. All education activity shall be suspended until further notice.

13. The sanitary instructions of the Museum's security personnel and gallery wardens must be strictly followed during the visit.

14. Photographing and filming in the exhibition area must not disturb

tourist traffic or be a nuisance to visitors. The right is reserved to prohibit the photographing of any items which are the property of the Museum or private individuals.

15. Failure to apply the required means of personal protection, persistent violations of the social distancing obligation or the gathering restriction will result in the visitor being expelled from the Museum.

16. Use of the cloakroom is not recommended due to the risk of transmission of coronavirus on outerwear and luggage.

17. No large backpacks, bags, suitcases, Nordic walking poles or any items which may pose a risk to exhibit security must be carried into the exhibition area.

18. In addition, the following prohibitions apply within the Museum premises:

- a) carrying firearms,
- b) carrying dangerous and sharp objects,
- c) bringing in animals (with the exception of guide dogs),
- d) smoking tobacco and electronic or no-smoke cigarettes,
- e) eating and drinking,
- f) visiting while under the influence of alcohol or drugs,
- g) talking on mobile devices,
- h) touching the exhibits,
- i) sliding on the floors,
- j) photographing and filming indoors with flash, additional lighting, tripods, and other accessories necessary for professional photography and filming,
- k) photographing and filming elements of security systems near exhibits and in the exhibition halls.

19. Men's and women's toilets are available to Museum visitors on the ground floor. Only one person may be in the toilet at the same time (with the exception of children under the age of 13 accompanied by parents or persons who require assistance). Means of personal protection (e.g. disinfectants) are available in the Museum's toilets.

### **SCULPTURE PARK AT THE KRÓLIKARNIA PALACE**

1. Only pedestrian traffic is allowed in the Park.
2. Bicycles and scooters must be left in racks designated for the purpose. The Museum shall not be responsible for any items of property left there.
3. Photographing and filming must not disturb tourist traffic or be a nuisance to visitors, and may only serve non-commercial purposes.
4. The visiting terms and conditions must be followed.
